

# MENDOTA GOLF CLUB

## General Rules and Regulations

### Section I                      Playing Priority

- A. Common courtesy dictates that slower players should allow faster players to play through, if there is at least one hole open ahead of the slow players. The club management may require enforcement of this rule.
- B. Golfers with power carts have no special priority over those walking. Do not crowd golfers on foot.
- C. Golfing groups larger than foursomes have no playing priority. These groups will only be allowed if permission has been obtained from the Club Attendant prior to beginning play.
- D. You must have permission from the Club Attendant to start on #10 tee.
- E. Members and guests are encouraged to make tee times in advance.

### Section II.                      Club Event Participation

- A. Participation in the adult Leagues and Tournaments will be limited to members 18 years old or older as of April 1<sup>st</sup> each year.
- B. Participation in Men's Stags is limited to members and guests of members. All participants in Men's Stags must be at least 21 years of age. Non members will pay an additional fee.

### Section III.                      Golf Carts

- A. Power golf cart usage on the Mendota Golf Course will be limited to the number of privately owned units and club owned units as determined and authorized by the Board of Directors. Only club owned, leased, or privately owned, club approved power golf carts may be operated on the golf course.
- B. Present renters of the cart spaces who do not plan to continue the rental and use of the space, must release their space to the Mendota Golf Club and the Cart Chairman will provide the space to the member first in line on the appropriate waiting list.
- C. All request for rental stalls must be in writing, dated and directed to the Cart Chairman. Request for cart spaces will only be accepted from full class members as determined by the Board of Directors.
- D. Request for cart spaces may only be listed in one player membership name. Present spouse may succeed in the ownership of a cart space when a family or couple membership is current.
- E. All riding carts stored on club premises must be of the gasoline powered type. All gasoline must be purchased from the club.

F. Cart spaces may only be rented to members who pay full current annual dues in the full class memberships as determined by the Board of Directors.

G. When spaces become available, the rental fee will be due and payable, and the space must be filled by the opening day of the next year. Non compliance will result in forfeiture of the cart space.

H. Golf cart operators must have a valid drivers license.

I. Not more than two riders nor three sets of clubs will be allowed on any golf cart.

J. Power carts must be kept at least 30 feet from all greens and tees.

K. Movement of any pull or power golf cart over greens, tees, moguls, nature areas, or sand traps is absolutely prohibited.

L. The use of power carts is banned during periods when so designated by the Course Superintendent or Club Manager.

M. All power carts are to be operated in the rough until close to the distance of your ball and then directly across the fairway to your ball; this is referred to as the 90 degree rule.

N. Request for Trail Fee Privileges may be made annually in writing to the Board of Directors. If granted the following rules apply:

1. The cart must be removed from the premises each evening.
2. There will be an annual fee to be determined by the Board of Directors.
3. Trailers or other conveyances must be parked in designated areas.

O. The Mendota Golf Club will not be responsible for theft, vandalism, safety or be liable in any way for damages arising out of the ownership or use of privately owned golf carts on the Mendota Golf Club property.

#### **Section IV. General Conduct**

A. Children under 13 years of age must be accompanied and supervised by an adult or preapproved by the Club Manager.

B. Proper golf attire must be worn at all times on club property by all members and guests without exception.

C. Importing of all beverages onto the club premises is absolutely prohibited.

D. Willful damage to club property by members or non-members is grounds for loss of club privileges and financial restitution.
